Registration & Refunds: Registration and payment for camp must be completed & submitted to FlyingTee to Camp@FlyingTeeGolf.com no later than 10 days prior to the camp date. Full payment is required at the time of registration to reserve the child's space. Due to limited space, refunds will not be given. Participants may sign up for any or all of the weekly camps. There will be no proration of fees for any days a child participant cannot attend.

Hours of Camp:

9:45am am drop off/check-in & 2:00pm parent pick up. Dates for the camp June 12th to 15th, June 19th to 22nd, June 26th to 29th, July 10th to 13th, July 17th to 20th, July 24th to 27th.

Dress Code: Children should dress appropriately for the activities scheduled. FlyingTee recommends shorts and a light weight shirt or top and some type of athletic shoe or sneaker in order to participate in recreational or athletic activities. Clothing that displays drugs, alcohol, tobacco, offensive languages, excessive bagginess or is excessively revealing will not be permitted. Sandals, flip-flops, rubber "croc" style shoes, and other open-toed shoes are not recommended as acceptable attire for active recreation activities.

Medical Needs/Allergies:

FlyingTee is not permitted to administer medication to program participants. In the event of a medical emergency, FlyingTee will administer first aid, CPR and rescue in the best interest of the child. Parents will be contacted if care is administered. Allergy medications may be administered if directed in writing by the child’s parent/guardian.

Pick-Up & Drop-Off Procedures:

Children need to arrive within 15 minutes of camp start time and be picked up within 15 minutes of camp end time. Parent/guardian must park their vehicle and walk their child into the facility and sign the child into the Camp. The parent/guardian must also come in to pick up their child as they will not be released from the building without parent pickup.

Late Pick-Up Policy:

There will be a late-fee assessed for children who are picked up after 2:00pm. The late fee is \$1.00 for each minute past 2:00pm. Repeated late pick-ups may result in the removal of the participant from the program, with no refund for pre-paid programs.

Special Circumstances:

Parents/guardians are required to inform FlyingTee in writing of any special circumstances which may affect the child’s ability to participate fully and within the guidelines of acceptable behavior, including, but not limited to, any serious behavioral problems or special circumstances regarding psychological, medical, or physical conditions. Once the notice is submitted, a conference will be scheduled with the parent/guardian to discuss the special circumstances and whether FlyingTee can accommodate the circumstances.

Personal Belongings:

Please put the child’s name on all articles of clothing, bags, etc. Children should not bring toys, mobile phones, electronic devices, jewelry, money or any possession of value with them to any of the programs. Children will be responsible for their belongings.

Sunscreen/Insect Repellent:

Please apply sunscreen and insect repellent prior to the start of each camp session. Children may bring sunscreen & insect repellent but must be able to reapply with staff supervision. Spray or mist sunscreen and/or insect repellent are recommended. Sunscreen and/or insect repellent must be labeled with child’s name. Children may not share these items with others.

Behavior Management/Discipline Policy:

FlyingTee staff will create a fun and safe environment for participants in the camp. Praise & positive reinforcement are used as effective methods of behavior management. Children who do not respond to these methods or who are destructive to others or to property will be addressed verbally in a professional, positive and timely manner to correct the behavior. The following procedures will be followed for behavior management.

- 1) A professional, positive and timely verbal correction will be addressed with child. Incident report will be provided to parent.
- 2) In the event a child’s behavior is a repeat behavior and cannot be corrected via step 1 the parent/guardian will be notified and the child may be dismissed from the camp.

NOTE: Immediate dismissal from the program can occur at any time given severe circumstances. Refunds for missed days due to a discipline dismissal will not be granted.

Waivers & Informed Consent:

By signing this form, I, as parent/guardian, permit FlyingTee to use pictures of my child(ren) as a program participant in promotional literature, videos and the FlyingTee website. I understand my child(ren)’s name(s) will not be published.

I, as parent/guardian of _____ (“child”), hereby assume all risks & hazards incidental to the conduct of the activities at FlyingTee. My Child is fit for the camp program(s) in which I have enrolled him/her. I PROMISE NOT TO SUE RELAEASEES ON MY BEHALF OR ON BEHALF OF MY CHILD REGARDING ANY CLAIM ARISING FROM OR RELATED TO MY CHILD’S PARTICPATION IN ANY FLYINGTEE PROGRAM(S).

I ACKNOWLEDE THAT, BY SIGNING THIS DOCUMENT, I AM RELEASING FLYINGTEE, ORIGIN LLC AND THEIR REPRESENTATIVES, AGENTS, EMPLOYEES, VOLUNTEERS, MEMBERS, SPONSORS, PROMOTERS, AND AFFILIATES (COLLECTIVELY “RELEASEES”) FROM LIABILITY, AND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS.
